Dear Parents/Carers,

Photo consent Years 9 - 11

We sought your consent on the data collection form when your child joined the academy for your child's digital image to be used for promoting the School, including marketing material such as the prospectus and update magazine, media, website and social media. In order to be compliant with GDPR regulations we need to change who is consenting for your child as they are now able to provide their own consent.

The GDPR regulations give children the same rights as adults over their personal data. These include the rights to access their personal data; request rectification; object to processing, have their personal data erased and consenting to the use of their data. When relying on consent, we must have to ensure that the child understands what "consent" means. In order to help them to fully understand this we will be talking to them in tutor time.

Although the regulations give children full rights over their data we also appreciate that parents will want to know what their child is consenting to. There is a standard consent form attached to this letter so you can see clearly what is being requested. Children in Years 9-11 will be able to give their own consent as is their legal right, but we would hope that as parents/carers you talk to them about this matter, as we will in the ways described above. We will be completing these forms during their tutor period in the first week back after half term.

We really value using these videos and photos to be able to showcase our amazing students and their achievements as well as show what life at our academy is like.
